ORDER

Whereas it has been brought to the knowledge of the undersigned that the condition of NH-302 between Lunglei and Tlabung has deteriorated to such an extent that it is not only difficult but also unsafe for vehicles to ply on the said road;

And whereas the association of maxi-cab owners, called *Lunglei Thlang Joint Maxicab Services* has called for suspension of their services indefinitely with effect from today, the 24th of July, 2023 for the above-stated reason, and has also sought the support of other commercial non-passenger transport services;

And whereas an urgent meeting was convened by the undersigned with the NHIDCL representatives and the contractors today wherein the contractors were directed to undertake repair and improvement of critical stretches immediately;

And whereas it is also considered necessary to enable the contractors to execute the said repair and improvement of critical patches of the road without hindrance and distraction so that the road can be opened to traffic at the earliest possible;

Now, therefore, the undersigned, in exercise of the powers conferred by sec 34 (a), (b) and (m) of the Disaster Management Act, 2005, hereby directs that –

- (a) the section of NH-302 between Hauruang and Tlabung shall be closed to normal traffic **from 0600 Hrs of 26.07.2023 till 0600 Hrs of 28.06.2023**
- (b) no vehicle other than those on medical emergency duty, election-related duty, disaster-related duty and law and order duty (executive magistrates and police personnel), carrying special detailment order or referral letter from the competent authorities shall be allowed to ply on the above-mentioned stretch of road during the specified period
- (c) the newly assigned contractor, namely, BRN Infrastructure Pvt. Ltd shall ensure that the road is pliable for all categories of vehicles from 0600 Hrs of 28.07.2023 without fail.
