ORDER

Whereas an Order dated 24.07.2023 was promulgated under Sec 34 (a), (b) and (m) of the Disaster Management Act, 2005 for closing the section of NH-302 between Hauruang and Tlabung to normal traffic from 0600 Hrs of 26.07.2023 till 0600 Hrs of 28.07.2023 to enable the newly assigned contractor, BRN Infrastructure Pvt Ltd to undertake emergency repair of critical stretches of the road without hindrance and distraction;

And whereas it is learnt that the condition of NH-302 between Lunglei and Tlabung has not improved due to lack of reaction time for the contractor, and hence, the suspension of services of maxicabs continues;

And whereas an emergency meeting was convened this afternoon by the undersigned under the chairmanship of the Vice-Chairman, Lunglei High-Powered Committee which was attended by the Hon'ble MLA, 33-Lunglei South AC, Superintendent of Police, Lunglei, General Manager, NHIDCL (PMU-Lunglei) and representatives of BRN Infrastructure Pvt Ltd, Lunglei Thlang Joint Maxicab Services and Zoram Drivers' Union to discuss the most expedient way of improving the condition of the road so that vehicles of all categories can ply without risk of accidents;

And whereas after a detailed deliberation, the meeting agreed to the proposal of NHIDCL for closing the road to trucks and heavy vehicles for a period of 48 (forty eight) hours to enable the contractors to execute emergency repair and improvement of the critical patches of the road without interruption and distraction;

And whereas BRN Infrastructure Pvt. Ltd also assured that this temporary restriction will enable them to improve the road significantly as they have now deployed adequate men and machinery at the project site;

Now, therefore, the undersigned, in exercise of the powers conferred by sec 34 (a), (b) and (m) of the Disaster Management Act, 2005, hereby directs that –

- (a) the section of NH-302 between Hauruang and Tlabung shall be closed to medium and heavy vehicles (Tata 407 and above) for 48 hours **from 0600 Hrs of 04.08.2023 till 0600 Hrs of 06.08.2023;**
- (b) all medium and heavy vehicles shall plan their movement accordingly;
- (c) BRN Infrastructure Pvt. Ltd shall ensure that the road is pliable for all categories of vehicles from 0600 Hrs of 06.08.2023 without fail.
