ORDER
(Section 163 of BNSS, 2023)

(English version)

Whereas bursting of firecrackers during festive seasons resulted in increase in pollution level besides causing noise pollution affecting the general public especially old aged people, infants, sick, and bedridden people;

And Whereas sky lantern and plastic pellets firing toy guns endanger human life and adversely affecting our environment,

And Whereas I am of the opinion that there are sufficient grounds for invoking the provision of Section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023 to prevent injury, safeguard the health of the public, and protect against danger to human life during the coming Diwali Celebration;

Now, therefore, the undersigned, in exercise of the powers conferred by the aforesaid Code hereby orders that *no person shall import, possess, store, display, buy or sell fire crackers, sky lanterns and toy guns (releasing plastic bullets or projectiles) within Lunglei District;*

This Order shall take immediate effect and shall remain in force for a period of 2 (two) months from the date of issue unless revoked earlier.

Violation of this Order shall be punishable under *Section 223, Bharatiya Nyaya Sanhita (BNS), 2023.*

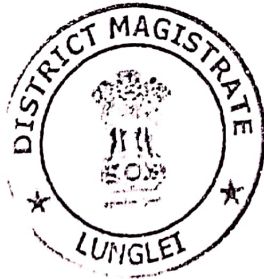
