TERMS & CONDITIONS :

1. The Vehicles can be inspected by interested persons on 14.10.2024 – 25.10.2024 during office working hours in the presence of Office Superintendent at Deputy Commissioner's Office, Lunglei.
2. The bidder should deposit earnest money of Rs for MZ-02/A-1777 (Bolero) and Rs for MZ-02/A-2348 (Bolero) in the form of 'Deposit at Call' duly pledged in favour of the Deputy Commissioner, Lunglei in the State Bank of India or any other Government recognized Bank.
3. The tender should be submitted in the prescribed form which can be obtained from the office of the Deputy Commissioner, Lunglei on any working day and must be accompanied by the requisite Earnest Money Deposit in the form of 'Deposit at Call' as indicated above.
4. The bidder should quote his/her bid amount/outright price both in figures and in words for any of the vehicle bided for on 'As is where is' basis and should also indicate his/her contact number. Any correction/over writing must be initiated by him/her without which the tender will be liable to rejection.
5. The tender should be submitted in sealed envelope addressed to the Deputy Commissioner, Lunglei District, Mizoram which must be super scribed as '**TENDER FOR CONDEMNED VEHICLE**' indicating the registration number and type of the vehicle tendered for.
6. The tender should be submitted separately for each vehicle along with complete documents mentioned above.

7. The envelopes containing tenders should be put into the tender box kept in this office for the purpose. The tender should be submitted during office hours on or before 29.10.2024 (Tuesday) up to 4:00 PM. The tender box shall immediately thereafter and the tender received shall be opened on 30.10.2024 (Wednesday) at 11:00 AM in the presence of the bidders or their representatives who may like to witness the opening of the tenders.
8. No complaint will be entertained if the bidder or his representative is not present at the time of the opening of the tenders.
9. The successful bidder shall have to deposit full amount of the bid money within 5 (five) days from the date of issuance of acceptance of his/her tender, failing which it will be treated as cancelled and offer will be made to the second highest bidder and so on.
10. The successful bidder shall have to lift the vehicle after making full payment of the settlement amount (Sale price) within 10 days after the issuance of release order failing which he/she will be required to pay an additional garage rent at the rate of Rs 50/- per day.
11. The undersigned reserves the right to reject all or any tender without assigning any reasons. Tender not accompanied by requisite Earnest Money shall be summarily rejected.
12. If the Quotationer withdraws after opening of the Tender, he/she forfeits the earnest money already deposited and it will credit into Government accounts.
